FOREWORD:


Parish plans are community led; they are produced by and for communities. The Hound Parish Plan is no exception and is based on a detailed consultation involving the whole community. It has been brought together by a small but dedicated team of volunteers who make up the Hound Parish Plan Steering Group and who share a common interest in ensuring a positive future for our local surroundings and the people who live, work and play here.

The Plan is designed to prompt local action and influence others, such as local councils and businesses. This document is the result of much research within the Hound community including local organisations, youth groups, businesses, visitors and residents.

The findings draw heavily on the results of the questionnaire which was circulated throughout the Parish. The Hound Parish Plan Steering Group realises that the needs of the community will probably change and develop over the years and therefore what follows is a 'working document' to be adapted and amended from time to time. Some of the actions should be achievable in the near future whereas it is recognised that some are longer term.

The Hound Parish Plan Steering Group invites individuals, the Hound Parish Council and in turn Eastleigh Borough and Hampshire County Councils to embrace the vision of the plan and use the ideas presented here to shape the future of Hound.

The Hound Parish Plan Steering Group offers sincere gratitude to all of those who have contributed and helped to create an interesting and credible plan for our future.



HOUND PARISH

The Doomsday Book of 1085 records two manors in this area, one at Hune (Hound) and another at Latelie (Netley). The exact location is uncertain but they were most likely sited in the north of the Parish in the area known as Old Netley with a total population of about sixty. Traditionally the Priory of Hamble was responsible for the founding of St Mary's at Hound in 1230. One can only surmise that there was a small population in this vicinity at that time. Henry the Third was responsible for the founding of the Abbey in 1239 and it is this which gives the name to the largest settlement in the Parish. The Abbey was occupied by the Cistercian order of monks, a reclusive order which preferred locations remote from centres of population and which subsisted on the yield of the farms and woods they owned. The population of the Parish at that time was therefore small.

After the Dissolution of the Monasteries in 1536 the Abbey and its lands became the property of Sir William Paulet, Baron Beauchamp and first Marquis of Winchester, Comptroller of the Royal Household of Henry the Eighth. The Abbey itself was converted into a major dwelling. He was also responsible for the construction of Netley Castle in 1547. It is recorded that Elizabeth the First visited Netley Castle in 1560. The Abbey fell into disrepair and the Castle became a country house in 1660. In the eighteenth and nineteenth centuries the ruined Abbey became a tourist attraction and many famous people visited it including the artist John Constable.

In 1821 the population of the Parish was only 387. The large rise in population in the area was a consequence of the building of the Royal Victoria Hospital in 1856. By 1861 the population of Netley Abbey village had increased to 2,039. The military hospital, which was visited by Queen Victoria on several occasions, provided employment opportunities for a civilian population and a demand for goods and services from local establishments. Many ex-service personnel settled in the Parish. In 1951 the population numbered 7,223, a figure similar to that of today but now extending over a greater built-up area. The Hospital closed, and was demolished in the 1960s.

The Parish now consists of the major settlement of Netley Abbey village and the two smaller areas of Butlocks Heath and Old Netley. It extends from the Southampton Water coastline almost to the M27. Much of Hound Parish is open space and farmland forming a green gap between the surrounding settlements of Southampton City to the north-west and Bursledon, Hamble and Hedge End to the north and east. The major open spaces include the site and grounds of the Hospital with the Chapel remaining as a centrepiece of the now Royal Victoria Country Park administered by Hampshire County Council. Other major sites include Westwood, Priors Hill Copse, and Netley Common together with a number of smaller sites.

Apart from the Abbey Ruins and Castle, which are Scheduled Ancient Monuments, there are other heritage interests in the Parish with several listed buildings and particularly a thirteenth century church at St Mary's Hound. The Victorian centre of Netley Abbey village is a conservation area. Access to the shoreline is limited and the clay and gravel cliffs are eroding although the Solent Shoreline Management Plan has a policy of "holding the line". The walk along the sea wall fronting the Royal Victoria Country Park has had to be closed because of instability, much to the regret of many locals and visitors.

HOUND PARISH PLAN

In response to an appeal by the Hound Parish Council, and having received a briefing on the construction of parish plans, a small group of volunteers met in September 2010 to offer their services to produce a parish plan for Hound. These volunteers became the Hound Parish Plan Steering Group in January 2011 which was formally constituted in February 2011. This group, although partly funded by the Parish and Borough Councils was totally independent. The first task was to clarify the nature and extent of Hound Parish and bring it to the attention of the public. This was done with displays of posters and maps, together with a plea for more people to become involved.

Next was the task of arousing interest in the plan itself. To this end flyers were distributed and notices posted in the News Hound and Scene publications. As it was important that the views of the younger generation should be considered, a competition for classes at Netley Abbey Junior School was designed on the theme of their likes and dislikes of the area and designs for the future. This was carried out in June/July 2011. Eight books of beautifully coloured drawings, photographs and relevant text, as well as a model of their playground by one class – rated by them as the best place in Netley – were submitted. Young adults from the Parish at HYPE (Hamble Young Person's Experience) were also given the opportunity to express their opinions with a questionnaire designed and collected by Donna Brewer, the Manager of HYPE at the time. The various Scout and Guide organisations also completed a simplified version of the main questionnaire. These views form the basis of the Young Persons' section of the Plan.

To get an impression of the issues facing Hound Parish it was decided to hold two Open Days where these topics might be raised. Local organisations were invited to present displays designed to raise awareness of the character of Hound and the active groups within it. To involve as many people as possible Open Days were held, one at Abbey Hall, Netley Abbey and one at Hound Parish Hall, Butlocks Heath, in September 2011. Posters and an interview on Radio Solent with Dick Smith, Hound Parish Councillor, advertised the events and explained the purpose of a parish plan. Those who attended the Open Days were given the opportunity to express their views on "post its" stuck on boards with headings such as Housing, Traffic, Leisure etc. It was from these comments that the bulk of the later questionnaire was derived. The design of the questionnaire on which the final Plan was to be based occupied the Steering Group for the next few months and was completed by March 2012. Copies were distributed one per household, and collected in ballot boxes at various locations and by members of the Steering Group, their friends and Explorer Scouts in the wettest Spring in living memory (see Acknowledgements). By the middle of May some 650 completed questionnaires had been returned, a rate of over 20%.

These returned questionnaires were analysed and summarised by the Steering Group resulting in the publication of this Parish Plan for Hound in December 2012. This work is produced entirely by a very small group of volunteers, with no previous experience, motivated by the desire that local people should have a voice in the future of Hound Parish.

QUESTIONNAIRE RESPONSES IN SUMMARY

DEMOGRAPHICS

Main Questionnaire:

Over **3000** questionnaires were delivered and some **650** completed or partially completed questionnaires were returned – over **20%**. The total number of persons providing an input numbered some **1342**, a number derived from the household composition question. As the total population of Hound at the last published census of 2001 was just over 7000, this too represents just more than 20%.

The breakdown by age of these 1342 respondents was as follows:

0-15yrs - **184**, 16-30yrs - **123**, 31-45yrs - **207**, 46-65yrs - **425**, 66yrs+ - **403** Note that the last two categories covered a larger age range than the first three.

Returns were received from **146** different post codes, with 38 returns omitting the post code, which represents almost the entire Parish.


Young Persons' Section:

158 children from Netley Abbey Junior School were involved in a project about their views of the Parish and their hopes for the future.

51 young people aged 11 to 25 from the Parish completed a brief questionnaire at HYPE (Hamble Young Person's Experience) on Transport, Community Facilities, Environment and Belonging.

33 young people from the local Scout and Guide organisations and a few other children completed the "Like/Dislike", "Would like to see / Would Not like to see", questionnaire.

The "blue italic quotes" in the following pages are selected comments from the questionnaire respondents. Most other comments are available in the Appendices. It was felt that as many comments as possible should be published as the greatest complaint from individuals was that "no one listens". The views expressed in these comments are not those of the Group – just a few were considered unsuitable to be published.

PLANNING AND HOUSING

There was overwhelming support (93%) for the maintenance of Hound as a separate entity surrounded by green, undeveloped space.

There was some support for more building to provide more facilities but with increased population density. However, 73% did not approve.

If more residential accommodation is to be built in the Parish there is a preference for family homes, retirement accommodation and starter/affordable homes and a strong vote against buildings over three storeys high (almost 97%).(See graph below and Appendices)

If commercial sites are developed there is a strong preference for more leisure facilities, a marginal vote for more retail outlets, and disapproval of more offices, light industry or distribution developments. There may be support for more intensive use of existing business premises if it results in more local jobs. However as 4 of the top 5 "dislikes" are about traffic and parking this would need careful planning.

In the section "Things I would not like to see in Hound" an overwhelming number featured strong opposition to more building, gravel extraction in Hamble, more flats, increased traffic, overdevelopment and development of green belt land.

"Hound PC should keep up opposition to gravel extraction in Hamble. Hound will be affected in many ways. Already too many deaths in Hamble Lane"


"No more overdevelopment like the Station Hotel site which is totally out of character and is obscene. How was this development ever passed – it is a disgrace"

"Keep the area accessible but rural. We want both residents and visitors to enjoy this lovely area in peace"


Actions:

- Present the results of this plan to the relevant planning authorities to explain the strength of feeling against overdevelopment and potential loss of green space.
- Ensure that the interests and views of local residents are considered in all planning applications.
- Establish an effective means of communication to mobilise support for or opposition to contentious planning applications.

TRAFFIC AND TRANSPORT

Like other parishes, Hound has problems associated with motor vehicles whether in motion or stationary. The increase in the number of vehicles in recent times on a street system designed for a smaller population with less universal car ownership has led to congestion in some areas and heavy, fast-moving traffic in others. Congestion is exacerbated by parked cars and the use of large delivery vehicles to supply retail premises.

The reduction of the speed of traffic on the main roads through the three settlement areas is seen to be of major importance (70%). Paradoxically, congestion and parked vehicles near the shopping areas slow the traffic but increase the danger to pedestrians crossing these roads as visibility is impaired, and fast-moving traffic on some main link roads poses a threat to children on their way to school. (See Appendices)

The layout of some road junctions leaves something to be desired (80%) adding to the congestion, confusion and danger to pedestrians in Netley village centre. Some junctions away from the central areas connecting to busy routes are seen as inadequate, bordering on dangerous. (See Appendices)

Despite the congestion in Netley village centre, the reorganisation of traffic flows to form a one-way system of movement is largely viewed as impractical (75%). The main solution is seen to be the strict limitation of parking on the main roads near the centre.

In some areas vehicles have been parked across pavements and verges to allow traffic greater access. This can cause a major inconvenience to many (42%) particularly those with mobility scooters or pushchairs. However the removal of grass verges to allow parking (22%) is generally seen as a retrograde step, endangering the green aspect of the Parish. The only area where this finds some favour is close to schools and where houses lie back from the road across expanses of grass.

Due to the intensity of traffic it is suggested that pedestrian crossings should be installed (57%) in the centre, particularly as there are many elderly people in the population whose sight and mobility may not be perfect, and to protect children on their routes to schools when crossing the main roads.

The attitude to cyclists is somewhat ambiguous. Some people are inconvenienced by cyclists on pavements (22%) where there are no specified cycle lanes - others wish to see more, and more continuous, cycle lanes. It is recognised that the siting of these is problematical given the narrowness of most roads and pavements.

In some places to be a pedestrian is seen to be dangerous (54%) because of the lack of proper footpaths beside some of our "country lanes".

Nearly 80% of the respondents work outside the Parish but very few use public transport for this journey. The use of public transport for other purposes is much greater although a sizeable proportion never use public transport. Public transport is seen as expensive, infrequent, and liable to delays, and with limited routes. (See Appendices)

"The junction at Station Road/ Victoria Road needs reconfiguring before there is a serious accident"

"Laws relating to cycling and parking are not enforced"

"Traffic congestion has become far worse leading to various problems in Victoria Road and, disastrously, in Hamble Lane"

"Speed of cars and motorbikes etc along St Mary's Road/Hound Way is daunting"

Traffic and Transport continued:

- Oppose one-way system in Netley centre.
- Propose 20mph speed limit on Pound Road, Victoria Road, Station Road, near schools, Woolston Road (through Butlocks Heath) and Ingleside. Establish traffic calming measures, electronic warning signs on upper Station Road, Victoria Road, Ingleside.
- Propose main road junctions to be improved at Grange Road/Woolston Road, Grange Road/Portsmouth Road, Station Road/Victoria Road, Station Road/New Road, Hamble Lane/Satchell Lane and Sellwood Road/St Mary's Road.
- Request restricted parking in Netley centre, no parking across pavements, particularly on lower Station Road, Victoria Road, New Road and Woolston Road, Butlocks Heath. Traffic Wardens to be in evidence to enforce existing restrictions.
- Support improved parking around schools with transformation of grassed areas to accommodate.
- Request construction of pedestrian crossings at lower Station Road and on Hound Way.
- Rationalise the construction of more cycle lanes to complete network, encourage use rather than cycling on the roads. Cyclists to be prosecuted for using pavements where there is no cycle lane indicated.
- Recommend footpath on upper Grange Road and Woolston Road, north-west of Butlocks Heath.
- Consult with service providers to improve reliability of bus service, weekend services and extend routes, and increase frequency of stopping trains at Netley Station.
- Advocate lowering the cost of all public transport, and improving frequency and punctuality.





CRIME AND SAFETY

A significant proportion of households are comfortable with regard to their safety, with 515 out of 605 respondents (85%) indicating that they do feel safe in Hound. When asked what would make residents feel safer, the most comments (181) wanted a more visible police presence and the next highest (69) highlighted control of speeding traffic and enforcement of existing restrictions.

125 out of 638 households (20%) indicated that they or a member of their family had been a victim of crime within the last two years, of which 86% confirmed that they had reported the crime to the police. The main reason for not contacting the police was highlighted as 'minor theft- not worth reporting' with 8 comments.

With regard to graffiti or vandalism, 246 out of 592 respondents (42%) indicated that they had experienced this in Hound. Bus stops were the main concern with 50 comments, followed by Station Road Recreation Ground with 41 comments.

Many households (224 out of 610 or 37%) indicated that they have experienced anti-social behaviour within Hound. 30 respondents commented on groups of youths within the village, whilst 21 comments were made about drunken behaviour outside the village pubs and clubs.

195 out of 609 households (32%) indicated that they are part of a Neighbourhood Watch Scheme, whilst 80 respondents (13%) did not know.

When answering the general question - 'What would you like to see in Hound?' - two main areas related directly to crime and safety were:

Traffic calming/speed control (38 comments)
More Police/PCSOs (44 comments)

- With a large percentage of households in Hound experiencing vandalism or graffiti (42%), an objective must be to identify and improve target areas in order to reduce this figure.
- The responses suggest that there is a real opportunity to engage people in the Neighbourhood Watch Scheme with 68% of completed questionnaires indicating that they were not in or did not know of a scheme within their area.
- Promote responsible drinking in all ages, but discourage underage drinking wherever possible to prevent anti-social behaviour.
- Request more police/PCSO presence in the evenings.
- Traffic calming action as in Traffic & Transport.

HEALTH

The majority of respondents, over 71%, were satisfied with the Health Centre in Satchell Lane. Just over 10% were not, and almost 19% of respondents did not use this facility.

Of those not satisfied, reasons cited were the poor location, car park too small, too far for old people to get to and the old surgery being more convenient, but the biggest complaint was difficulty obtaining an appointment of their choice.

Over 88% do not need further advice or help on any health issues not currently available or accessible, but 11% would like to see extended services such as dentist, physiotherapy and alternative medicine available locally.

Almost 65% agreed that young people should have access to health services other than their family doctors, although comments were made that "Doctors should advertise that they maintain confidentiality" and that "Young people should be cared for by their parents".

A total of 172 respondents had difficulty accessing local health services. For 65 this was because of transport issues and for 50 of them mobility problems but 46 blamed the opening hours.

Air quality/pollution is a cause of concern to 35%, with 53% of that number thinking that Fawley Refinery was the source of the pollution. 37% thought traffic, in particular in Hamble Lane, was a problem and that this will worsen if gravel extraction proceeds.

Having insufficient public toilets available in Hound was a concern for 42% of respondents, but 45% thought there were enough, questioning who would pay for more, and the kind of behaviour it would attract. Those in favour thought that central Netley, the library, car parks or near Sophie's Pond would be ideal sites for additional facilities. Station Road Recreation Ground and Butlocks Heath Recreation Ground were the other most favoured sites.

- Inform the Health Centre management of the findings regarding access and attempt to resolve these issues.
- Review transport to surgery and road crossings on Hamble Lane.
- Ensure the facilities for young peoples' health issues continue to be provided locally outside the GP service.
- Liaise with Fawley Refinery to ascertain pollution statistics, and confirm the source of the perceived air pollution.
- Monitor the traffic pollution statistics already being collected in Hamble Lane and ensure the Air Quality Action Plan now in place is effective.
- Augment the availability of public toilets in the Parish.

ENVIRONMENT AND LEISURE

Hound is fortunate in that it possesses within its boundaries many open spaces and woodland of all sizes. It also has large amounts of farmland across which there are footpaths and public rights of way. The Royal Victoria Country Park is by far the largest of these spaces. The other large areas of open space are Westwood, Priors Hill Copse and Netley Common. The other extensive area visited for leisure lies around the Cricket Field, Castle grounds and beach. (See Appendices)

There is general satisfaction with the maintenance and sign posts on the footpaths within the housing areas used by the majority of respondents. However the state of the footpaths across the countryside areas has been criticised in some cases.

The local play areas provided in the recreation grounds are well used both by families with young children (86%) and relatives of residents with young children.

Litter is seen as a big problem in the Parish (58%) and is to be found throughout.

Air pollution is seen as a problem by people who live near busy roads, particularly those living near Hamble Lane. This is coupled with noise pollution from the same source. Air pollution from the Fawley area is still noticeable on occasions.

The mess left behind by dogs being walked on pavements and footpaths is another great cause for concern (70%). Recently horses have left mess on pavements as well. Bags of dog excreta have been thrown into bushes and bins have overflowed. Fly tipping occurs occasionally mainly in isolated locations on the sides of the road or footpaths.

Anti-social behaviour is not seen as a major problem, being largely restricted to areas close to pubs and clubs late in the evening. In some areas gatherings of teenagers have caused concern.

Practically all respondents acknowledged the importance of protecting the shoreline. The reopening of the Royal Victoria Country Park sea wall walk was also seen as desirable. The shoreline and beach form a significant asset, mainly as an area to provide a relaxing environment (93%) and for walking. It was less used for fishing, all types of boating and swimming. This may be because of the concern for water quality.

The provision of further open-air amenities was supported by many people. There were other suggestions including some sort of lido/paddling pool and more activities for teenagers including a skate park. (See Appendices)

The library is practically unanimously seen as essential and it was noted that opening times are limited.

The historical sites in the Parish are considered to be well preserved, maintained and advertised (86%). There were some reservations about the maintenance of the Abbey grounds and the lack of advertising in the form of road signs.

It was generally felt that tourists were well catered for (75%). Some reservations were made about the provision for tourists in the Parish, there being little "bed and breakfast" accommodation, no tea rooms and no public toilets available close to historical sites. Road signage left room for improvement and information boards were felt to be inadequate by some.

"Netley has some terrific character: the village "feel", the Abbey, the foreshore, RVCP, and its proximity to some attractive countryside. I fear however that I have seen the best of it"





Q1. How many times do you visit RVCP, Priors Hill Copse, Westwood, Netley Common or other local areas?


Number of people using less than once a month




Use more than once a month




Use more than once a week




Is your neighbourhood subject to?



Do you use the shoreline for?




Do we need?



- Publicise information about all the large areas of open space and encourage more use by displays in the Parish Office. Produce larger and more informative signs at all access points to open space and improve maintenance and signage for countryside footpaths.
- Maintain and improve play equipment when necessary. Provide further open air facilities for adults and amenities for young people e.g. a paddling pool, skate park etc.
- Provide more and larger waste bins, particularly where there is major littering and these to be emptied more frequently with fines for dropping litter enforced. Encourage public participation in preventing litter and volunteering for litter picking.
- Provide more and larger dog mess bins and empty more frequently. Wardens to fine dog owners permitting dogs to foul pavements, grassed areas and recreation grounds. Encourage public participation in discouraging dog fouling. Encourage horse riders to be responsible for their horses' manure, and only to ride on roads and bridleways.
- Reduce traffic congestion on Hamble Lane as slow moving traffic creates most air pollution. Investigate cause of perceived air pollution from the Fawley area.
- Protect and maintain the shoreline. Publish water quality reports more prominently.
- Maintain and extend library services, and use of library building.
- Encourage improved amenities for visitors.

VOLUNTEERING

The majority of respondents did <u>not</u> volunteer in Hound (78%). Several said they volunteered outside the Parish, but those who did volunteer in Hound listed <u>24</u> different areas of involvement. These people were almost all involved with many more than one agency/organisation.

Only 10% of respondents said they had directly benefited from voluntary help. The question of indirect benefit was not addressed. However, the benefits of voluntary organisations such as youth groups, scout and guide associations, parish councils, sports associations, conservation organisations, church groups etc have an effect on everyone in the Parish so perhaps this is recognised by the 75% who said volunteering could make a difference to the quality of life in Hound.

78% would support a community-run cafe for social interaction, some saying it could be a place where all generations could mix, others wishing to restrict its use to adults. Some people were keen to point out the lack of a suitable site and the problems of staffing and "policing". Others highlighted the benefits of people knowing each other and that it would be a great place for many lonely people to meet.

Just over half of respondents felt a system of credits leading to rewards would encourage young people to be more involved in the community – although there were some who felt it was bribery or blackmail, rather than incentive, and that being a good citizen should be its own reward.

In response to "what would encourage you to volunteer?" most respondents said they needed more information from direct contact with people in local organisations. The majority however felt they were too old, too infirm or too busy with work or young families to do more voluntary work. This will become a greater problem as retirement age increases and our ageing population needs more support. It is vital therefore to provide information for those interested in just a small commitment, recognise the huge contribution to our community made by a relatively small number of volunteers working with many local organisations, and incentivise younger people to understand the benefits of good citizenship.

- Provide information on local volunteering, identifying a personal contact within an organisation. Promote better liaison between local groups to organise local events and support.
- Identify centres of social interaction e.g. a cafe, the library and make better use of the available facilities to reduce isolation in all ages within the community.
- Encourage younger people's involvement in the Parish by building on the established Together We Can CLIC campaign (agreement on rights and responsibilities in the community, at Netley Infant School).
- Encourage younger people to be involved with local projects in history, conservation, beach cleaning etc, so they feel part of and respect the community in which they live.

EMPLOYMENT AND BUSINESS

Fewer than half (42%) of respondents are economically active, either employed or self-employed. Of those, 20% were working within the Parish, assumed to be mostly the self-employed, working from home.

The majority of respondents wanted to see more local employment opportunities, with over half saying they would be willing for more places of employment to be built in the Parish, although often adding the caveat that development should be on brown-field sites wherever possible and that more use should be made of existing facilities such as empty shops and business units. Either way, concern was expressed on the impact that more local trade and business would have on parking and the transport links, chiefly Hamble Lane (see Traffic and Planning Sections).

35 respondents said that they would like help with setting up and running their own business in the area, some mentioning specifics and asking where they might get help. Almost all respondents wanted to support local business and liked the idea of a Hound Business Directory or Local Traders' Association.

In some cases, more local traders (and locally-produced goods) were called for and respondents would like to see them offer training, apprenticeships and employment to the local community, especially young people. The majority of people would like to see a free job and training advertising facility for local employers to reach candidates living in the Parish.

More than 500 respondents wish to see more banking facilities in the area; the Post Office offering many services but being more limited than the banks. More 24hr ATMs would be an improvement.

189 respondents would like to see more childcare, specifically pre-school day care or nurseries within the Parish – one noting that Hamble Lane traffic makes it difficult to access those that are out of area. This is a significant demand with one respondent describing this as a 'desperate need' and asking for advice on opening a nursery.

It was suggested that there is over-provision of child-minding (based on the reason given by Ofsted to refuse a new registration), although statistics on this subject have not been verified.

"A 24 Hr ATM would be good"

"Happy to see Netley as it is but realise young people may need more work and living areas"

"Very definitely need a nursery. Traffic in Hamble Lane to get to others is terrible"

"Small companies employing local people would benefit area, reducing travel costs giving more money to spend, increasing sense of community and purpose, reduce pollution and make Hound more than a large housing estate. No large companies – more small shops and businesses, local produce, locally-made products – from coppiced wood etc. More like the West Country villages visited while on holiday with small shops and tea rooms"

- Improve access to banking facilities.
- Identify site and childcare provider for nursery. Use plan results to assist in establishing need with Ofsted.
- Identify empty shops and offices for use. Negotiate competitive rates with landlords. Start up assistance.
- Support local traders by establishing a local business directory with free job/training advertising and also jobs wanted.
- Put educationalist looking for woodland space to develop young people's skills and knowledge in touch with Priors Hill Copse.

YOUNG PERSONS' SCHOOL PROJECT

"What do I really like in Netley?"

The area was seen as a very pleasant place in which to live. It has a peaceful and friendly atmosphere with plenty of green open spaces.

The Royal Victoria Country Park was especially mentioned for providing the opportunities for many activities.

Similarly, the recreation grounds with all their play equipment were also very popular.

The seashore and the Abbey ruins were also mentioned as attractive locations.

Experiences in school were favourably expressed.

"What would I like to see in the future?"

The most quoted was the desire for some kind of paddling/swimming pool facility.


The other major request was for a skate/cycle ramp with more challenging play equipment for older children.

More litter and dog mess bins would improve the environment, together with voluntary litter picking and dog owners more responsible for dog mess.

It was felt that a number of shops such as a sweet shop, a Legoland shop, a pet shop and a horse riding shop would improve the retail environment.





YOUNG PERSONS' RESPONSES (HYPE)

Transport - "What improvements would you like to see?"

It was felt that the bus service could be improved by introducing cheaper fares, more frequent buses and a fuller service.

The train service could also be improved with more frequent trains and fewer delays.

Community Facilities - "What do you need or would like?"

There was felt to be a need for bigger and better youth shelters in the recreation grounds together with skate ramps and more opportunity for outside activities with larger and well-lit cages.

Youth Clubs were thought to be lacking as were casual eating places such as a Greggs or Subway.

Environment - "What do you like and what would you like conserved?"

Woods, trees, recreation grounds, parks, and in particular Royal Victoria Country Park, should be protected, along with the wildlife, and not built over.

Belonging - "Do you identify with Hound?"

72% felt a sense of "belonging", giving as the main reason - pride in the sense of community with friends producing a happy and comfortable life in the village.

A minority felt that Hound was only for old people and the younger generation had no say in what happens.

YOUNG PERSONS' RESPONSES (Scout and Guide Associations and others)

"What do you like about Hound?"

The area was seen to be a safe place with a friendly community with facilities readily accessible. The Royal Victoria Country Park was particularly attractive and the recreation grounds with their play areas were considered an asset. The beach and woodlands were popular and the local shops were easily accessible.

"What do you dislike?"

While some did not dislike anything others mentioned the profusion of litter and dog mess, together with graffiti, spoiling the environment.

The areas of new housing and particularly blocks of flats were expressed as a concern, as was heavy traffic.

"What would you like to change?"

An improvement in street lighting and an increased police presence, improvements to traffic problems and provision of crossings and footpaths were the most requested changes.

"What would you like to keep the same?"

The countryside and wildlife including Sophie's Pond, along with the beach, open spaces, especially Royal Victoria Country Park and the recreation grounds were the most wanted to be kept the same.

Local shops, the Post Office in Netley Abbey, Butlocks Heath ex-Post Office, the Library, older houses and the village layout were also wanted to be kept as they are.

All comments from these responses are available in full in the Appendices.

CONCLUSION

The Hound Parish Plan Steering Group will meet regularly in the future to monitor the influence of the Plan on local bodies and the progress made with the Actions, and issue a periodic report via the Parish Council website. Additional volunteers are always welcome to join the Group.

Finally, the Hound Parish Plan Steering Group wishes to thank all those whose efforts and contributions have made this Plan possible, and trust that this is the start of an increased level of awareness, interest and appreciation of an excellent place to be.

The exterior of Abbey Hall is a mess! The plants and borders are overgrown with weeds. These could be looked after by volunteers or sponsored by local businesses in return for free advertising (like Bishops Waltham). Extend care along the sea wall and put plant tubs in these locations.

Cafe needed – a nice one, and a decent day nursery with 8 – 6 provision.

Opportunity missed, should have had offices and shops on Station Hotel site.

Vital to stop <u>any</u> more development because of Hamble Lane congestion.

Any banking facilities would be useful. The Post Office is limited. Happy to see Netley as it is but realise young people may need more work and living areas.

Lloyds bank is missed but the Post Office offers most services needed. A 24 Hr ATM would be good though.

Not enough opportunities for young people to do part time jobs locally. Local businesses should encourage apprenticeship schemes/interact with the community.

Lack of pre -school places and nursery.

No building development to provide jobs but use brown field sites and empty shops. (3)

Small companies employing local people would benefit area, reducing travel costs giving more money to spend, increasing sense of community and purpose, reduce pollution and make Hound more than a large housing estate. No large companies – more small shops and businesses, local produce, locally made products – from coppiced wood etc.

More like the West Country villages visited while on holiday with small shops and tea rooms.

Very definitely need a nursery. Traffic in Hamble Lane to get to others is terrible.

More business will encourage more people to live here forcing building on more land and choking the roads.

There needs to be more full time employment opportunities for young people. I do not believe that businesses are supported by the locals. It would be interesting to have a survey on shopping in the village apart from the 2 Co-ops.

2 Co-ops are not needed - one could be used for another business. Also the Parish Council should not occupy a shop and only open part time.

Businesses need more promotion, encouragement and variation. More information on where the shops are.

Post Offices provide a good banking service - could be expanded? Post Office handles banking for businesses.

There are too many childminders for me to get Ofsted Registration.

All residents need to support local business as they are 50% of blood supply to community.

Use every opportunity to get young meaningful employment. Too many children in childcare in today's society.

Growth will be difficult without improving access in and out of Hound - Hamble Lane!

Expanded school to anticipate some future training requirements is an excellent move.






More places of employment to be built in Parish?

- I consider it important to keep Netley and Butlocks Heath as they are with no more building work we do not want to be another Hedge End. We must protect our green open spaces. Protect the green in Priory Rd by wooden posts to stop parking (especially from school run mums) early spring flowers
- Poor focus on sport on Hamble peninsula. Community school had money poured in but my child, a keen runner and swimmer, left school with no interest in physical activity.
- · More speed limits.
- Hampshire Music Service offers no help to local groups and public transport limits access to Eastleigh, Winchester and Fareham
- Remove all no cycling signs from paved/tarmac footpaths
 e.g. Station Rd to Seaview Estate, Station Rd to Wykeham Rd,
 Hound Rd to Station Rd.
- Bins outside Indian takeaway by bakery in Victoria Rd should be located elsewhere - total eyesore.
- Appreciate the opportunity to voice opinion. Thank you.
- I enjoy living in the area. I would like everyone to appreciate how fortunate they are to be a resident of Hound.
- Great place to live and well run.
- Heritage site (RVCP) doesn't draw in local residents.
- Thanks for chance to have a say.
- Playgrounds need modernising.
- There is a farming community i.e. Pickwell Farm, stables etc.
 It would be nice if the huge amount of horse riders were given as much consideration as cyclists, walkers etc in this area.
- If Hamble Lane becomes a 30mph speed limit then Hound Way should definitely follow suit if only for the safety of the school children.
- Email addresses should be used where possible to save on paper.

- At the Hound Rd to Netley station cycle path there need to be signs to RVCP. Police should patrol down Hound Rd at least once a night.
- Please look at other thriving communities that have clubs, local shops, scout troops, fetes, carnivals, garden parties and use these as an example. There seems to be little to celebrate in Hound. Southampton and surrounding areas have a huge and valuable heritage from its maritime and aeroplane industries. Hamble airfield, with its Air Training core (sic) Fairey works, Aerostructures and all the boat building too we celebrate none of this other than in a fairly disappointing Museum of Aviation in Southampton. We should be making something of it! It could be a real tourist hot spot/ I hope for the best, but as I said previously there seems to be nothing to celebrate around here.
- To finish I would say that the area is very overpopulated. You only need to look at Google Earth to see how much of our local area is just grey with buildings! The thought of more housing is too much. There is precious little green space that people need for walks, peace and relaxation. The few wooded and green areas we have, like Hamble airfield <u>MUST BE PRESERVED</u> and not built on. Gravel extraction and more housing would be the nail in the coffin for the Hound area.
- Better planning behind Hound Parish Hall as in timing could have been better as the number of nests, eggs and baby birds are not compromised or destroyed. It is now looking very bear (sic) as all that was needed was the removal of stippling trees and the hard pruning of ferns and brambles not rare plants and honeysuckle. What was beautiful full and lovely place to visit is now a bear (sic) area with trees very ugly and booring (sic). Try getting someone who knows what they are doing next time.
- Burger van should be done away with, it attracts drunks into the
 area, causes anti social behaviour and we get the litter everywhere
 and we think outside of St Mary's Church is a most inappropriate
 place to sight a burger van because the drunks use the cemetery
 as a rubbish tip and toilet.
- Street cleaners seem to forget about Hound Way, always rubbish everywhere. Not good-the entrance to Netley- first impressions.
- Grange Lane is far too narrow. The buses go over the middle white line making it dangerous for cars coming the other way. The road needs widening in this area (entrance to St Edwards Rd) and up towards the bridge and footpaths needed over the railway bridge.
- Hamble Lane -it is time it was made into a dual carriageway or something needs to be sorted out. Been terrible for over 40 years!
- I love living in Netley most friendly, interesting easily accessible location.
- Plan consultation is a good idea. We hope the info will be acted on.
- Thanks for all the efforts of the people involved in this unpaid community work.
- Shame about the awful development on Station pub site.
- RVCP is being destroyed & run as a commercial business.
- Over development of Station pub site no infrastructure.
- More community support needed against anti-social neighbours.
- Hound Parish Council should have more say over EBC planning.
- I was born here & perhaps do not want to see the village I remember further destroyed.
- Thanks for doing this.
- It's very good that you put this survey together and time spent listening to residents. If any changes are made as a result of this feedback, please let us know.
- Castle Road needs more parking- wasted space on Green by nos.4,6,8,10 etc. disabled & old people having to walk to their cars so have to walk over the grass to be dropped off with their shopping.

BACK PAGE COMMENTS continued:

- Q 2 is a leading question. It should be broken down to ask about various levels of population density.
- Netley is too populated, poor facilities ie school overcrowded, too many flats. We need to stop building flats & build to support families.
- All dwellings and business premises granted permission in future must have adequate onsite parking.
- Thank you for the opportunity to "have a say", generally this is still a nice place to live despite all the changes of the past 30 odd years.
- Could trader/shop owners be encouraged to install canopies similar
 to the baker's? Would improve the look of the shops which do look
 a little tatty, particularly the chemist!
- Lorries using small roads (i.e. New Road) because of Sat Navs.
 These roads are not meant for lorries and it is very dangerous for the elderly people and children who live in these roads. Please, someone, help stop this before someone gets killed.
- Thank you for the opportunity for feedback.
- Hope you get lots of feedback preferably from younger people.
 Us "oldies" tend to like things the way they are!
- Stop cars/vans parking on pavements. Very dangerous for disabled & prams.
- Help for the elderly in their properties & gardens.
- Only to say how much I appreciate the work you are putting into this. I've said earlier in the survey that our community spirit is what makes the village a wonderful place to live & your efforts add immeasurably to that spirit.
- It would be nice if funding could be found to open up the seawall/ shoreline walkway between the entrance to RVCP & the memorial in the park. It used to be lovely on bright days to walk along there, but that has been closed for at least the last couple of years because of land sliding down the embankment.
- The Co-op lorries are too big for the village. They block Victoria Rd & Station Rd.
- We think that Netley is the best part of Southampton and we need to keep it that way.
- Community spirit in Netley is part of a good way of life generally.
- Protection of RVCP & the Abbey is essential.
- Bus stop layout at the dry cleaner's is not helpful.
- I live in Butlocks Heath & would like to see more signage explaining that Woolston Rd is a village road through Butlocks.
- Netley has a lot of dogs and animal lovers. We need more bins in the parks.
- With regard to fluoridation, we now have to buy bottled water, as we strongly disagree with enforced medication.
- All business & communal premises must have legally binding assigned responsibility for maintenance upkeep of grounds and boundaries & proper landscaping.
- No development should impact the natural light of existing dwellings.
- Hound needs to attract high tech scientific, environmentally friendly technologies e.g. science park.
- For every new dwelling built in the Parish at least one permanent local job must be created to avoid the area becoming a dormitory of Southampton.
- The formal green spaces being Victoria Park, Priors Hill Copse, Netley Abbey, Westwood, Netley Common, Abbey Hall, shoreline, St Mary's Church, St Edwards Church and horse troughs MUST BE RETAINED.

- No expansion of Netley and Hound Parish should occur unless road access to and from the M27 is significantly improved preferably via Shop Lane and Grange Road to avoid residential area on Hamble Lane.
- David Airey did get road directional sign for new development adjacent to Recreation Ground not considered "URGENT" on completion of site. 2 years and 4 months later "Focus" printed "success" with D. Airey's photo. This delay caused anxiety to terminally ill husband missed hospital appointments and self standing out on Station Rd in nightclothes with torch to direct ambulance in!! With all new pockets of development in the area responsibility for signposting should be agreed with developer and local authority. Thanks to David Airey parking restrictions have been placed on Station Rd and some people still choose to ignore them.
- Upon moving to Netley Abbey in April 1984 my late husband and self attended any local meeting in order to establish ourselves. One, given by a PC Jones, encouraged attendees to "stand up & be counted". New build ie Ingleside, Abbeyfields & flats on shoreline would bring increased population and traffic. We always tried to integrate the community but on more than one occasion our concerns were dismissed by the existing local chairman as "trivial", "obviously newcomers who do not realise how much councillors do for you", Small wonder some residents say "why bother". 27 years later I have raised several issues with local councillors: being referred to EBC or Hampshire, written to Chris Huhne, spoken recently to Keith House (nil response). Replies from other persons invariably passed to another department, various reasons why no action at present.
- Substantial improvements have been made over the 40 years that
 we have been residents of Netley but there are still many
 opportunities for further improvements, and I welcome the
 chance to input them.
- Although the questionnaire is about Hound most of our answers are about Netley. Hound is not a community, but an administrative construction embracing three quite different communities, each with its own individual needs. One size will not necessarily fit all in every situation.
- Hound consists of three distinct areas Old Netley, Butlocks
 Heath and Netley Abbey. The strategic centre of the Parish is
 Netley Abbey and there is a problem to ensure that whilst both
 Old Netley and Butlocks Heath receive a fair share of "services,
 time and effort" there is also a mechanism to ensure that there is
 no over compensation either.
- Whilst I am clear that residents of Hound contribute financially to the Parish I am less certain of the contribution businesses make to the Parish financially.
- It has been great to have the opportunity to comment about Netley and the surrounding area as I love to live here. I think it would be good to have more opportunities to get to know people who live here and go to events for local people. Hamble & Bursledon hold events in their village halls which are aimed at the local community. It would be great to have that in Netley occasionally.
